FUNDING OPPORTUNITY

Funding areas and specific grant opportunities that tie to individual applications.
Funding Opportunities have a parent-child hierarchy to relate individual funding programs to larger initiatives.

INDIVIDUAL APPLICATION

Grantees will create individual applications from the Grants portal that is comprised on a workplan, budget, supporting documentation, and any compliance or legal terms.

FUNDING AWARD


The award given to an individual or organization. If a funding award will be granted, grantors send grantees notices of funding awards (NOGA).

FUNDING DISBURSEMENT


Represents payment that has been made or scheduled to a grantee, either a one-time payment or installments based on the disbursement schedule established by the grantor.

PROGRESS REPORTS

Progress reports can be easily tracked and maintained in the grants management application.
Grantees can upload related documentation to the granting organization directly from the portal.
