

**SECOND AMENDMENT TO PARTICIPATING ADDENDUM**

This Second Amendment to the Participating Addendum, dated as of this 17th day of April 2020, is entered into by and between the **Carahsoft Technology Corporation (“Carahsoft”)** and **Georgia Department of Administrative Services (“DOAS”)**.

WITNESSETH

WHEREAS, Carahsoft and DOAS have previously entered into the Participating Addendum dated October 14, 2019 (the “PA”); and

WHEREAS, Carahsoft and DOAS have previously amended the Participating Addendum by that certain amendment dated November 21, 2019 (the “First Amendment”); and

WHEREAS, in consideration of adding Service Providers to the Participating Addendum, the Parties wish to amend and add additional provisions to the terms and conditions of the Participating Addendum; and

WHEREAS, in consideration of adding Service Providers to the Participating Addendum, the Parties wish to amend Appendix A to the Participating Addendum,

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the premises, the mutual promises, covenants, and agreement contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

1. **Amendment:** The PA is hereby amended to incorporate the terms and provisions of this Amendment. If any terms contained in the PA are in conflict with any terms or provisions of this Amendment, the terms and provisions of this Amendment shall control. All other capitalized terms used herein and not otherwise defined herein shall have the meanings set forth herein. Except as expressly amended herein, the terms and conditions of the PA shall continue in full force and effect.
2. Section 1, Paragraph 4 of the Participating Addendum is deleted in its entirety and replaced with the following:

The above-listed Cloud Services may be obtained from the Service Providers identified in Appendix A to this Participating Addendum. No Purchasing Entity may purchase Cloud Solutions from a Service Provider who is not listed in Appendix A and whose products or services have not been approved by the Participating State. A list of approved

products or services for each Service Provider listed in Appendix A is maintained by the Participating State. No terms and conditions of Service Providers (including but not limited to sub-contractors, resellers, and partners) will be considered binding on the Participating State, a Participating Entity, a Purchasing Entity, or the Contractor other than the terms and conditions attached as an Exhibit to Appendix A. Any documents containing terms and conditions that are in conflict with the terms and conditions or that contain terms and conditions beyond the scope of this Participating Addendum and the documents attached to Appendix A are not binding on the Parties. The Participating State may amend Appendix A to add or remove Service Providers as necessary. Amendment of Appendix A must be made in writing as an amendment to this Participating Addendum, signed by the parties and approved as required by the laws of the State of Georgia.

3. Appendix A is amended and replaced with the attached.
