Leveraging the Technology Modernization Fund for IT Transformation

The GSA's Technology Modernization Fund (TMF) provides federal agencies with funding to replace outdated IT systems. Agencies must align proposals with TMF goals, complete a two-step submission process, and present to the Technology Modernization Board. Projects must demonstrate measurable outcomes that address real customer and operational needs.

At the end of 2024, the NTSB chose Box as its intelligent content platform to enhance efficiency and improve citizen engagement, using TMF to fund its modernization.

Better citizen engagement and experiences

The National Transportation Safety Board (NTSB) partnered with Box to power its Digital Content Delivery Platform, replacing outdated ECM systems with a secure, scalable, intelligent content layer. With Box, the NTSB enables investigators to easily upload and manage multimedia content, curate and publish reports through portals, and ensure data security. The result is improved public access to investigative reports. This transformation allows the NTSB to deliver a streamlined and transparent experience for investigators and the public.
