Who is eligible for the promotion?

- US Federal Agencies only

How can I purchase?

- Purchase could be made via GSA MAS IT, NASA SEWP, NIH NITAAC, and DOW ESI Contract Vehicles

I already have a BPA or IDIQ at my agency for Box. Can I leverage that for my purchase?

- Yes, GSA and any previously mentioned contract vehicle-based BPA contracts can be utilized to obtain the promo

I am an existing Box customer. Can I take advantage of the promotion?

- Yes, existing customers may take advantage of the promotional discount at the time of their renewal

How is Box Priced during the promotion?
