

**AMENDMENT NUMBER 01 (“Amendment”)

THIS AMENDMENT NUMBER 01 is by and between the State of Louisiana (“Participating State”) and Carahsoft Technology Corporation (“Contractor”).

WHEREAS, the State of Utah (“Lead State”) has a Contract with the Contractor identified as Master Agreement No. AR2472 effective October 15, 2016 through September 16, 2026, to provide Cloud Solutions; and

WHEREAS, the State of Louisiana and Carahsoft Technology Corporation have executed a Participating Addendum, which is administered and utilized by the State of Louisiana as State Contract Number 4400010663; and

WHEREAS, the terms of the Participating Addendum specifically state that the Participating Addendum may be amended per agreement by both parties.

NOW, THEREFORE, it is agreed by the parties to amend the Participating Addendum as follows:

Changes:

1. 1st paragraph revised to read as follows:

The following products or services are included under this Participating Addendum and State Contract Number 4400010663:

- Infrastructure as a Service (IaaS)
- Platform as a Service (PaaS)
- Software as a Service (SaaS)
- Information Technology related Professional Services
- Information Technology related Consulting Services

All Services are allowed to be purchased **only** at the time of the purchase of the Cloud Solutions and the Services are to be directly related to the Cloud Solutions being purchased under State Contract Number 4400010663.

2. Section 6.A., deleted in its entirety.

3. ADD, the following language to Section 6. Modifications and/or Additions to the Master Agreement:

Q. Contractor's Certification of No Federal Suspension or Debarment:

By signing this Participating Addendum, the Contractor certifies that their company, any subcontractors, or principals are not suspended or debarred by the General Services Administration (GSA) in accordance with the requirements in "Audit Requirements in Subpart F of the Office of Management and Budget's Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards" (formerly OMB Circular A-133).

A list of parties who have been suspended or debarred can be viewed via the internet at <https://www.sam.gov>.

The Contractor has a continuing obligation to disclose any suspensions or debarment by any government entity, including but not limited to General Services Administration (GSA). Failure to disclose may constitute grounds for suspension and/or termination of this Participating Addendum and State Contract Number 4400010663 and debarment from future contracts.

R. Secretary of State Registration Requirement:

In accordance with Louisiana law, all corporations (see La. R.S. 12:262.1) and limited liability companies (see La. R.S. 12:1308.2) must be registered and in good standing with the Louisiana Secretary of State in order to hold a purchase order and/or a contract with the State.

S. Prohibition of Discriminatory Boycotts of Israel:

In accordance with La. R.S. 39:1602.1, for any contract with a value of \$100,000 or more and for any Contractor with five or more employees, the Contractor, or Subcontractor, shall certify that it is not engaging in a boycott of Israel and shall, for the duration of its contractual obligations, refrain from a boycott of Israel.

The State of Louisiana reserves the right to terminate this Participating Addendum, State Contract Number 4400010663, or any order issued pursuant to State Contract Number 4400010663, if the Contractor, or any Subcontractor, engages in a boycott of Israel during the term of this Participating Addendum, State Contract Number 4400010663, or any order issued pursuant to State Contract Number 4400010663.

T. Prohibition of Companies that Discriminate Against Firearm and Ammunition Industries:

In accordance with La. R.S. 39:1602.2, the following applies to any contract with a value of \$100,000 or more involving a for-profit company with at least 50 full-time employees:

Unless otherwise exempted by law, by entering into this Participating Addendum, the Contractor certifies the following:



1. The company does not have a practice, policy, guidance, or directive that discriminates against a firearm entity or firearm trade association based solely on the entity's or association's status as a firearm entity or firearm trade association;
2. The company will not discriminate against a firearm entity or firearm trade association during the term of this Participating Addendum and State Contract

Number 4400010663 based solely on the entity's or association's status as a firearm entity or firearm trade association.

The State reserves the right to terminate this Participating Addendum, State Contract Number 4400010663, or any order issued pursuant to State Contract Number 4400010663, if this certification is subsequently determined to be false, or if the certification is no longer true.

All other provisions, terms and conditions of the Participating Addendum shall remain in full force and effect. The original Participating Addendum and all Amendments constitute the entire Participating Addendum between the State and the Contractor. Any other oral or written communications between the parties before or after its execution shall not alter its effects, unless the change or modification is in writing and signed by authorized representatives of the State and the Contractor. In the event of a conflict between the terms and conditions of the Participating Addendum and this Amendment Number 01, the terms and conditions of this Amendment Number 01 shall prevail.
