


These legacy solutions:



Leveraging the Technology Modernization Fund for IT Transformation

The General Services Administration's (GSA's) Technology Modernization Fund (TMF) provides federal agencies with funding to replace outdated IT systems and offers financial flexibility and expert guidance for projects. The TMF supports modernization efforts that increase efficiency, improve security, and better serve citizens. It aims to ensure that taxpayer dollars are spent wisely and that technology investments yield positive results.

Agencies must assess whether their project aligns with the TMF's goals and priorities to take advantage of this unique federal investment model. Once a determination is made, agencies proceed through a two-step proposal process, followed by a pitch to the Technology Modernization Board for a vote. All projects must include key customer and agency outcomes that can be measured to confirm that TMF investments address real customer pain points and operational inefficiencies.

At the end of 2024, the National Transportation Safety Board (NTSB) chose Box as its Intelligent Content Management platform to enhance efficiency and improve citizen engagement, using the TMF to finance their modernization efforts.



Better citizen engagement and experiences

The NTSB sought a provider to serve as the intelligent content layer for its Digital Content Delivery Platform Project. The agency examined its organization's design, systems, and data to adopt a modern approach with integrated AI across the platform.
