**Carahsoft Rider to Manufacturer End User License Agreements**  
**(for U.S. Government End Users)**

- 1. Scope.** This Carahsoft Rider and the Manufacturer End User License Agreement (EULA) establish the terms and conditions enabling Carahsoft to provide Software and Services to U.S. Government agencies (the "Client" or "Licensee").
- 2. Applicability.** The terms and conditions in the attached Manufacturer EULA are hereby incorporated by reference to the extent that they are consistent with Federal Law (e.g., the Anti-Deficiency Act (31 U.S.C. § 1341(a)(1)(B)), the Contracts Disputes Act of 1978 (41 U.S.C. § 601-613), the Prompt Payment Act, the Anti-Assignment statutes (31 U.S.C. § 3727 and 41 U.S.C. 15), 28 U.S.C. § 516 (Conduct of Litigation Reserved to Department of Justice (DOJ), and 28 U.S.C. § 1498 (Patent and copyright cases)). To the extent the terms and conditions in the Manufacturer's EULA are inconsistent with the Federal Law (*See* FAR 12.212(a)), they shall be deemed deleted and unenforceable under any resultant orders under Carahsoft's contract #GS-35F-0119Y, including, but not limited to the following:
  - (a) Contracting Parties.** The Government customer (Licensee) is the "Ordering Activity", "defined as an entity authorized to order under GSA contracts as set forth in GSA ORDER 4800.2G ADM, as may be revised from time to time. The Licensee cannot be an individual because any implication of individual licensing triggers the requirements for legal review by Federal Employee unions. Conversely, because of competition rules, the contractor must be defined as a single entity even if the contractor is part of a corporate group. The Government cannot contract with the group, or in the alternative with a set of contracting parties.
  - (b) Changes to Work and Delays.** Subject to GSAR Clause 552.243-72, Modifications (Federal Supply Schedule) (July 200 0) (Deviation I 2010) (AUG 1987), and 52.212 -4 (f) Excusable delays. (JUN 2010) regarding which the GSAR and the FAR provisions shall take precedence.
  - (c) Contract Formation.** Subject to FAR Sections 1.601(a) and 43.102, the Government Order must be signed by a duly warranted contracting officer, in writing. The same requirement applies to contract modifications affecting the rights of the parties. All terms and conditions intended to bind the Government must be included within the contract signed by the Government.
  - (d) Audit.** During the term of this Agreement: (a) If Ordering Activity's security requirements included in the Order are met, Manufacturer or its designated agent may audit Ordering Activity's facilities and records to verify Ordering Activity's compliance with this Agreement. Any such audit will take place only during Ordering Activity's normal business hours

contingent upon prior written notice and adherence to any security measures the Ordering Activity deems appropriate, including any requirements for personnel to be cleared prior to accessing sensitive facilities. Carahsoft on behalf of the Manufacturer will give Ordering Activity written notice of any non-compliance, including the number of underreported Units of Software or Services ("Notice"); or (b) If Ordering Activity's security requirements are not met and upon Manufacturer's request, Ordering Activity will run a self-assessment with tools provided by and at the direction of Manufacturer ("Self-Assessment") to verify Ordering Activity's compliance with this Agreement.

- (e) **Termination.** Clauses in the Manufacturer EULA referencing termination or cancellation the Manufacturer's EULA are hereby deemed to be deleted. Termination shall be governed by the FAR 52.212-4 and the Contract Disputes Act, 41 U.S.C. §§ 601-613, subject to the following exceptions:

Carahsoft may request cancellation or termination of the License Agreement on behalf of the Manufacturer if such remedy is granted to it after conclusion of the Contracts Disputes Act dispute resolutions process referenced in Section Q below or if such remedy is otherwise ordered by a United States Federal Court..

- (f) **Consent to Government Law / Consent to Jurisdiction.** Subject to the Contracts Disputes Act of 1978 (41. U.S.C §§ 7101-7109) and Federal Tort Claims Act (28 U.S.C. §1346(b)). The validity, interpretation and enforcement of this Rider will be governed by and construed in accordance with the laws of the United States. In the event the Uniform Computer Information Transactions Act (UCITA) or any similar federal laws or regulations are enacted, to the extent allowed by law, it will not apply to this Agreement, and the governing law will remain as if such law or regulation had not been enacted. All clauses in the Manufacturer EULA referencing equitable remedies are deemed not applicable to the Government order and are therefore deemed to be deleted.
- (g) **Force Majeure.** Subject to FAR 52.212 -4 (f) Excusable delays. (JUN 2010). Unilateral Termination by the Contractor does not apply to a Government order and all clauses in the Manufacturer EULA referencing unilateral termination rights of the Manufacturer are hereby deemed to be deleted.
- (h) **Assignment.** All clauses regarding Assignment are subject to FAR Clause 52.232-23, Assignment of Claims (JAN 1986) and FAR 42.12 Novation and Change-of-Name Agreements, and all clauses governing Assignment in the Manufacturer EULA are hereby deemed to be deleted.
- (i) **Waiver of Jury Trial.** All clauses referencing waiver of Jury Trial are subject to FAR Clause 52.233-1, Disputes (JUL. 2002), and all clauses governing waiver of jury trial in the Manufacturer EULA are hereby deemed to be deleted.
- (j) **Customer Indemnities.** All Manufacturer EULA clauses referencing Customer Indemnities are hereby deemed to be deleted.

- (k) Contractor Indemnities.** All Manufacturer EULA clauses that (1) violate DOJ's right (28 U.S.C. 516) to represent the Government in any case and/or (2) require that the Government give sole control over the litigation and/or settlement, are hereby deemed to be deleted.
- (l) Renewals.** All Manufacturer EULA clauses that violate the Anti-Deficiency Act (31 U.S.C. 1341, 41 U.S.C. 11) ban on automatic renewal are hereby deemed to be deleted.
- (m) Future Fees or Penalties.** All Manufacturer EULA clauses that violate the Anti-Deficiency Act (31 U.S.C. 1341, 41 U.S.C. 11), which prohibits the Government from paying any fees or penalties beyond the Contract amount, unless specifically authorized by existing statutes, such as the Prompt Payment Act, or Equal Access To Justice Act 31 U.S.C. 3901, 5 U.S.C. 504 are hereby deemed to be deleted.
- (n) Taxes.** Taxes are subject to FAR 52.212-4(k), which provides that the contract price includes all federal, state, local taxes and duties.
- (o) Third Party Terms.** Subject to the actual language agreed to in the Order by the Contracting Officer. Any third party manufacturer will be brought into the negotiation, or the components acquired separately under Federally-compatible agreements, if any. Contractor indemnities do not constitute effective migration.
- (p) Installation and Use of the Software.** Installation and use of the software shall be in accordance with the Rider and Manufacturer EULA, unless an Ordering Activity determines that it requires different terms of use and Manufacturer agrees in writing to such terms in a valid task order placed pursuant to the Government contract.
- (q) Dispute Resolution and Venue.** Any disputes relating to the Manufacturer EULA and to this Rider shall be resolved in accordance with the FAR, and the Contract Disputes Act, 41 U.S.C. §§ 7101-7109. The Ordering Activity expressly acknowledges that Carahsoft, on behalf of the Manufacturer, shall have standing to bring such claim under the Contract Disputes Act.
- (r) Limitation of Liability: Subject to the following:**
- Carahsoft, Manufacturer and Ordering Activity shall not be liable for any indirect, incidental, special, or consequential damages, or any loss of profits, revenue, data, or data use. Further, Carahsoft, Manufacturer and Ordering Activity shall not be liable for punitive damages except to the extent this limitation is prohibited by applicable law. This clause shall not impair the U.S. Government's right to recover for fraud or crimes arising out of or related to this Government Contract under any federal fraud statute, including the False Claims Act, 31 U.S.C. §§ 3729-3733.
- (s) Advertisements and Endorsements.** Unless specifically authorized by an Ordering Activity in writing, such use of the name or logo of any U.S. Government entity is prohibited.

**(t) Public Access to Information.** Manufacturer agrees that the EULA and this Rider contain no confidential or proprietary information and acknowledges the EULA and this Rider will be available to the public.

**(u) Confidentiality.** Any provisions that require the Licensee to keep certain information confidential are subject to the Freedom of Information Act, 5 U.S.C. §552, and any order by a United States Federal Court.

**PRESTO ENTERPRISE MASHUP PLATFORM USER SOFTWARE LICENSE AGREEMENT**

THIS PRESTO ENTERPRISE MASHUP PLATFORM USER SOFTWARE LICENSE AGREEMENT (the "License") is made between the end user ("Customer"), and JackBe Corporation, a Delaware corporation ("JackBe").

**1. Grant of License.** JackBe grants to Customer a non-transferable, non-exclusive, limited license to (i) use the JackBe SOFTWARE and certain third party software that Customer downloads, in object code form only and any modifications provided by JackBe (collectively, the "SOFTWARE") and any related Documentation for internal use only; and (ii) make copies of the Software solely for back-up or archival purposes and for running the Software on multiple servers; provided, that Customer complies with the terms and conditions of this Agreement, including, without limitation any license restrictions set forth in each Purchase Agreement.

**2. Restrictions on Licenses.** This License does not permit you or any third party to: (i) modify, translate, reverse engineer, decompile, disassemble or otherwise attempt to discover the source code of all or any portion of the Software (except to the extent that this restriction is expressly prohibited by law); (ii) modify, translate or create derivative works of all or any portion of the Software; (iii) copy the Software onto any public or distributed network, sublicense, rent, lease, sell, offer to sell, distribute, or otherwise transfer rights to the Software; (iv) transfer or export any product, process, or service that is the direct product of the Software. (v) remove any proprietary markings, copyright, notices, logos, trademarks, trade names or labels on the Software and/or Documentation; (vi) use the Software on any computer not controlled by you; (vii) use the embedded database software as a general SQL server, as stand-alone database or with applications other than the Software; or (viii) use the Software to create any applications for development or evaluation for a fee charged to a third party. Except as expressly set forth in Section 2, no licenses of any kind are granted hereunder, whether by implication, estoppel or otherwise. If you make any modifications or derivative works to the Software, you hereby assign and agree to assign to JackBe all right, title and interest in and to such modifications and/or derivative works.

**3. Third-Party Software.** The software distributed by JackBe includes certain "Third-Party Software" which JackBe licenses from third parties which is subject to other terms and is not included in the definition of Software. You may view the relevant licenses for such Third-Party Software by visiting [<http://www.jackbe.com/enterprise-mashup/third-party-licenses>]. The Third-Party Software is subject to the terms of such licenses and Section 2 ("Third-Party Software"), Section 5 ("Warranty Disclaimer") and Section 6 ("Limitation of Liability") of this Agreement. You agree to comply with terms and conditions contained in all such Third-Party Software licenses.

**5. Warranty Disclaimer.** NEITHER JACKBE NOR ITS LICENSORS MAKE ANY WARRANTIES, WHETHER EXPRESS, IMPLIED, STATUTORY OR OTHERWISE. ALL IMPLIED WARRANTIES AS TO THE SATISFACTORY QUALITY, PERFORMANCE, MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NONINFRINGEMENT ARE EXPRESSLY DISCLAIMED TO THE MAXIMUM EXTENT PERMITTED BY LAW. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF IMPLIED WARRANTIES SO THE ABOVE EXCLUSIONS MAY NOT APPLY TO YOU. NEITHER JACKBE NOR ITS LICENSORS WARRANT THAT THE SOFTWARE OR THE THIRD-PARTY SOFTWARE IS ERROR-FREE OR THAT ITS USE WILL BE UNINTERRUPTED. JACKBE IS NOT OBLIGATED TO PROVIDE YOU WITH ANY UPDATES TO THE SOFTWARE BUT MAY ELECT TO PROVIDE YOU WITH UPDATES IN ITS SOLE DISCRETION.

**6. Limitation Of Liability.** NEITHER JACKBE NOR ITS LICENSORS SHALL BE LIABLE FOR SPECIAL, INCIDENTAL, EXEMPLARY, CONSEQUENTIAL OR INDIRECT DAMAGES, RELATED TO THIS LICENSE, INCLUDING WITHOUT LIMITATION, LOST PROFITS, LOST SAVINGS, OR DAMAGES ARISING FROM LOSS OF USE, LOSS OF CONTENT OR LOSS OF DATA, REGARDLESS OF THE LEGAL THEORY ON WHICH SUCH DAMAGES MAY BE BASED, AND EVEN IF JACKBE OR ITS LICENSORS HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH

DAMAGES AND REGARDLESS OF WHETHER ANY REMEDY SET FORTH IN THIS LICENSE FAILS OF ITS ESSENTIAL PURPOSE. BECAUSE SOME STATES/COUNTRIES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF LIABILITY FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES, THE ABOVE LIMITATION MAY NOT APPLY TO YOU. IN NO EVENT WILL JACKBE'S AGGREGATE LIABILITY UNDER THIS LICENSE EXCEED THE TOTAL FEES PAID BY CUSTOMER. ADDITIONALLY, IN NO EVENT SHALL JACKBE'S LICENSORS BE LIABLE FOR ANY DAMAGES UNDER THIS LICENSE.

**7. Intellectual Property Rights.** All rights, title and interest, in and to intellectual property embodied in the Software and any improved, updated, modified or additional parts thereof, shall at all times remain the property of JackBe or its licensors. The Software is protected by United States copyright laws and international treaty provisions. You may not remove the copyright notice from the Software or the Documentation. Nothing herein shall give or be deemed to give you any right, title or interest in or to the same except as expressly provided in this License. JackBe reserves all rights not expressly granted in this License.

**4. Limited Warranty.** JackBe warrants that the unmodified Software will perform substantially in accordance with JackBe's published specifications therefore for a period of ninety (90) days from the date of delivery to Customer, providing Customer uses the Software in accordance with JackBe's documentation. JackBe disclaims any warranty or representation to any person other than Customer with respect to the Software. JackBe's entire liability and Customer's exclusive remedy for non-conformity with the foregoing limited warranty shall be, at JackBe's option, either (i) return of the price paid for the Software and cancellation of this License, or (ii) repair or replacement of the affected Software. In order to obtain warranty remedies Customer must notify JackBe in writing of any non-conformity within the warranty period. This limited warranty is void if failure of the Software has resulted from modification, accident, abuse, or misapplication. Any replacement Software will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer.

**6. SUPPORT AND UPGRADES.** This agreement entitles Customer to product support, upgrades, patches, standard product enhancements, and fixes for the Software upon payment of annual software product maintenance fees. Customer is not entitled to any other Support unless Customer makes separate arrangements for Support with JackBe and pays any fees associated with such Support. Any such Support for the Software that may be made available by JackBe shall become part of the Software and subject to this Agreement.

**8. Termination.** Without limiting any rights of JackBe, this License is automatically terminated if Customer violates this License. Upon termination, Customer must cease using and destroy the Software and all copies and portions thereof and all related documentation.

**9. U.S. Government End Users.** The Software under this License is "commercial computer software" as that term is described in DFAR 252.227-7014(a)(1). If acquired by or on behalf of a civilian agency, the U.S. Government acquires this commercial computer software and/or commercial computer software documentation subject to the terms and this License as specified in 48C.F.R. 12.212 (Computer Software) and 12.11 (Technical Data) of the Federal Acquisition Regulations ("FAR") and its successors. If acquired by or on behalf of any agency within the Department of Defense ("DOD"), the U.S. Government acquires this commercial computer software and/or commercial computer software documentation subject to the terms of this License as specified in 48 C.F.R. 227.7202 of the DOD FAR Supplement and its successors.

**10. General.** This License will be governed by and construed in accordance with the laws of the State of Maryland and the federal U.S. laws applicable therein, excluding its conflicts of law provisions, and you and JackBe agree to submit to the personal and exclusive jurisdiction of the courts located in Montgomery County, Maryland. The parties agree that neither the United Nations Convention on Contracts for the International Sale of Goods nor UCITA will apply to this License. The failure of either party to require performance by the other party of any provision hereof shall not affect the full right to require such performance at any time thereafter; nor shall the waiver by either party of a breach of any provision hereof be taken or held to be a waiver of the provision itself. If any provision of this License is found void and

unenforceable, it will be replaced to the extent possible with a provision that comes closest to the meaning of the original provision. In the event of any conflict between the terms and conditions of this License and the terms and conditions of any license agreements appearing with or in the software products comprising the Software, this License shall prevail. This License, and the documents referenced in this License, constitute the entire agreement between you and JackBe relating to its subject matter and all terms herein and supersede all prior or contemporaneous agreements or understandings.
