Spot Budget Shortfalls and Control Employee Spending

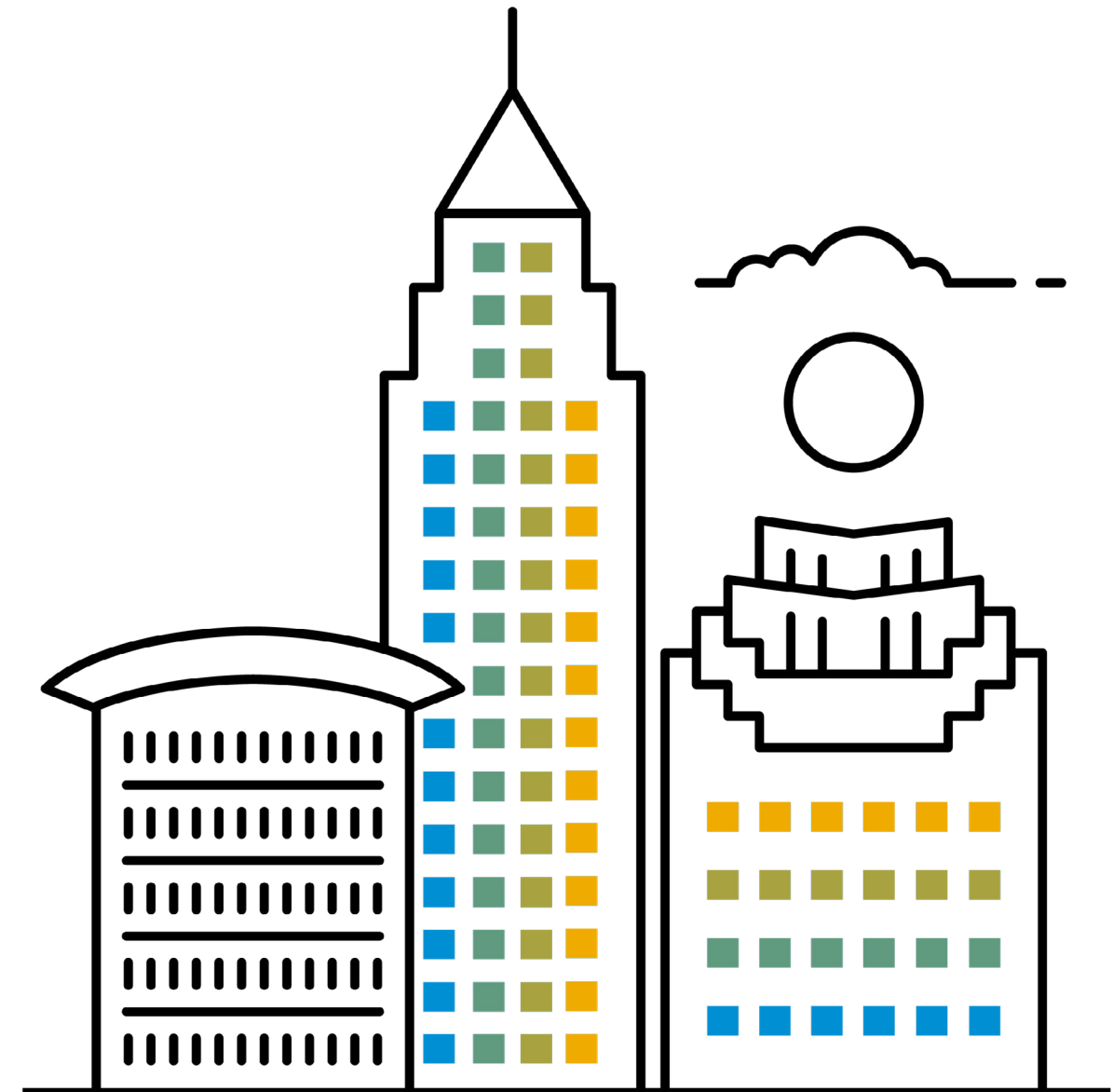
THE BEST RUN

Challenge

1 A Slow, Cumbersome Manual Expense Process

On any given day, there are an unknown number of expense reports out there orbiting the office. As employees sit down to pore over their crumpled reports, only to notice some of the receipts have been lost, they painstakingly copy details over to forms or spreadsheets while attempting to match credit card charges to the right expense lines. Although they aren't always sure if their expenses are within policy, they still print out their claim, staple receipts to their reports, make necessary photocopies, and cross their fingers it all goes through okay.

Sound familiar? This inefficient and error-prone expense process isn't only leaving your employees feeling frustrated, it's also lacking the visibility and insight you need to see where your city's budget is going.

Solution

Automate Expenses to Simplify

Automating your travel, expense, and invoice process takes away the cumbersome and manual tasks like populating spreadsheets, stapling receipts onto pieces of paper, copying, submitting, and filing expense reports – all which take up your team’s valuable time.

Challenge

2 No Visibility or Control Over Employee Spending

Spreadsheets, paper receipts, late submissions of expense claims, and lengthy approval processes all stand between you and a clear picture of your cash flow. Then there's other common expenses that often get left out of the picture like invoices, p-cards, and mileage.

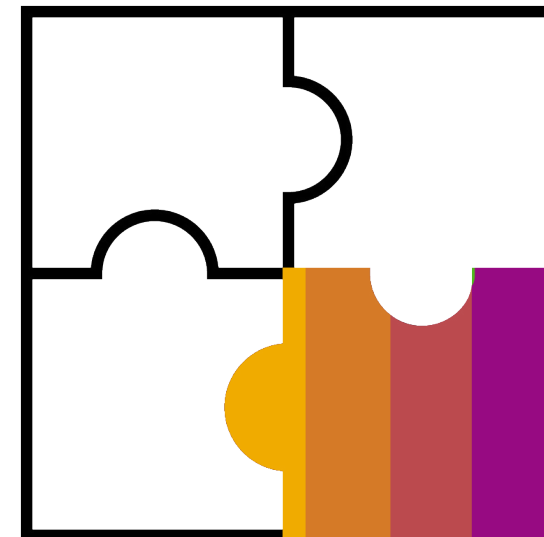

Solution

Challenge

3 High Risk of Incorrect and Fraudulent Payments

If you consider the tedious tasks behind completing an expense report, it's no surprise humans can make errors. In fact, a report from the Global Business Travel Association (GBTA) found that nearly 1 in 5 expense reports contain errors, costing an extra 52 dollars and 18 minutes to fix each one.¹ Unfortunately, acts of fraud can be even more detrimental. A report from the Association of Certified Fraud Examiners found the median loss of fraud for public administration to be \$125,000 per case and last a median duration of 16 months.²

If you don't know where your current policy is located or what it says, then chances are your employees don't know either – and that's an even bigger problem. Complicated, outdated, or nonexistent expense policies create compliance risks and leave your city vulnerable to fraud.

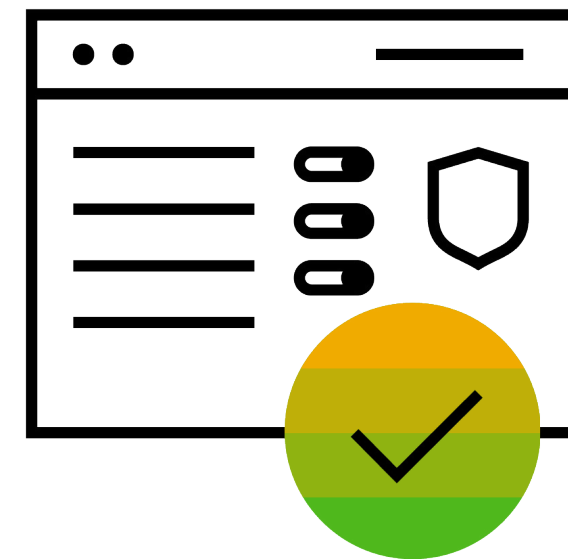

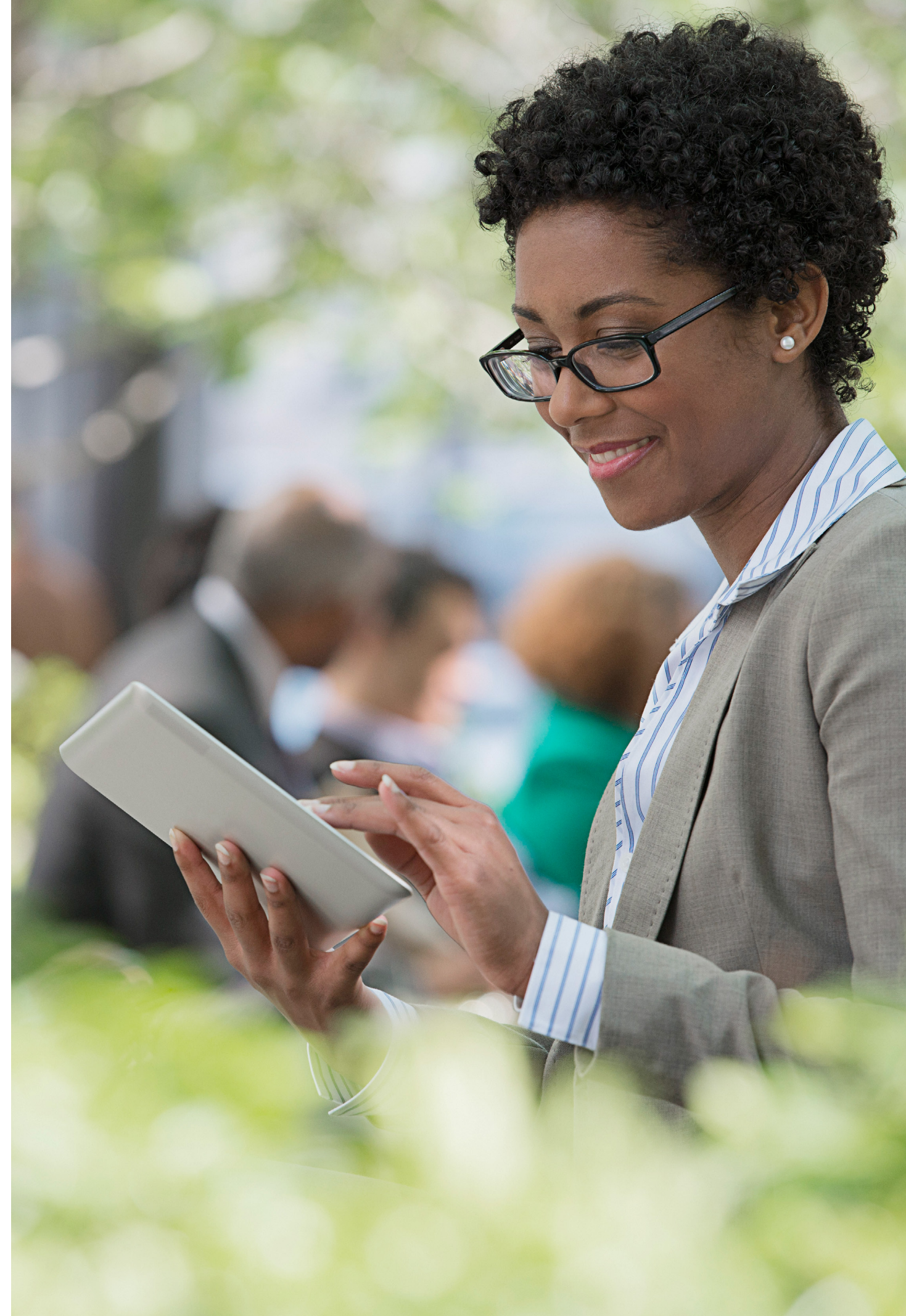
