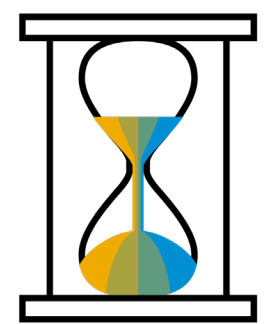

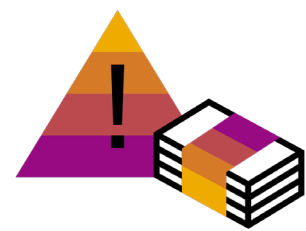
Top Spend Management Challenges for K-12 Schools

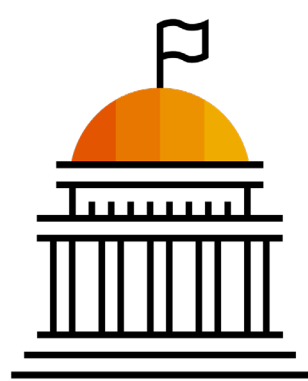
Slow manual spend management processes

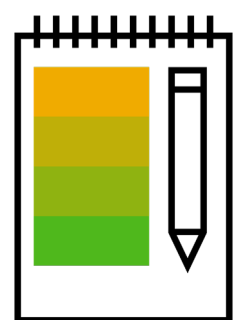
Lack of control over limited budgets

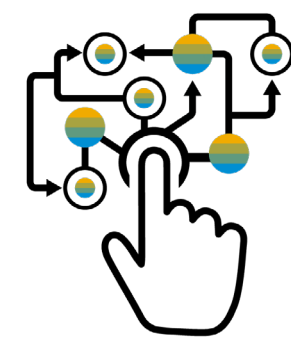
Cumbersome tools and technology

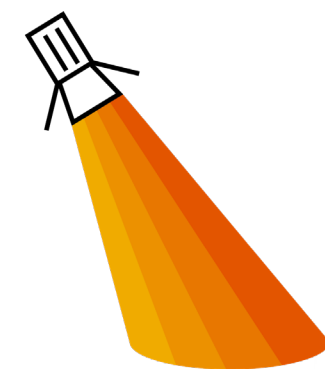
