Executive Summary

The United States Government has adopted the Microsoft Cloud at unprecedented rates in the past two years to support a remote workforce due to the COVID pandemic. Microsoft provides recovery for loss of service due to hardware or infrastructure failure, data center outage and natural disaster, as well as short term recovery of SharePoint and OneDrive (maximum 93 days) and Exchange mailboxes (30 days). However, most agencies do not realize that this does not include a granular backup & recovery solution for common scenarios including:

- Planner, Teams chats & discussions, Project, and other services which do not contain recycle bins;
- Protection of SharePoint beyond 93 days and Exchange beyond 30 days;
- Loss of data due to corrupted files or lack of versioning;
- Protection against Ransomware and other malicious outsiders;
- Storage of files and email after licenses are reassigned (e.g., employees on long-term TDY)

Most agencies do not realize the simple fact that while Microsoft provides disaster recovery capabilities, it does not have Backup & Recovery solution for many common scenarios


- Microsoft provides **restoration in the event of the loss of a service, site, or data center** based on their Recovery Point Objective (RPO). Data is retained temporarily in recycle bins and kept for no more than 90 days (often long before data loss is noticed) which cannot be relied upon to prevent permanent deletion.
- File Restore requires full rollback of site content to a single restore point no MORE than 30 days in the past. Restoration from backups can only be completed for site collections or sub-sites; not specific files, lists, libraries, plans, tasks, or permissions. Microsoft Support must be engaged with standard SLA.
- File Restore requires version history when version history is turned off the File Store option
 will not be available for restoring to a previous version. Permanently deleted items in Outlook are
 kept for a maximum of 30 days (14 by default) and can only be recovered using PowerShell scripts.
- In the event of a compromised Office 365 tenant (either due to hackers, Ransomware, or other malicious actions) a **third-party copy of the data needs to be maintained to provide recovery from off-site storage**.
