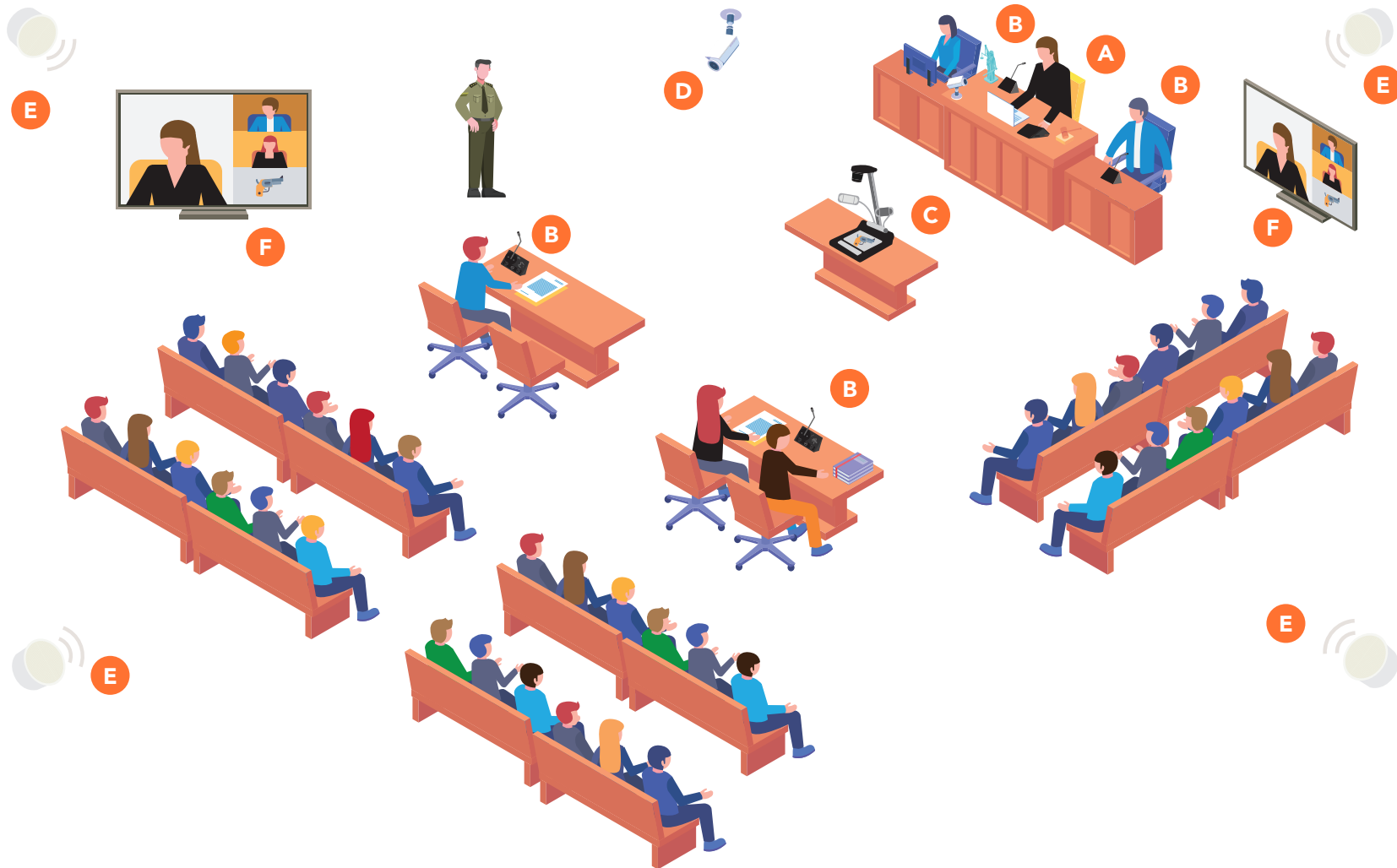

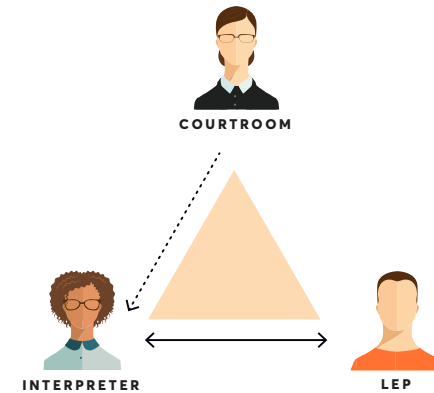
Interpreter modes

We provide support for three modes of courtroom audio: simultaneous To lep, simultaneous to court, and consecutive mode.

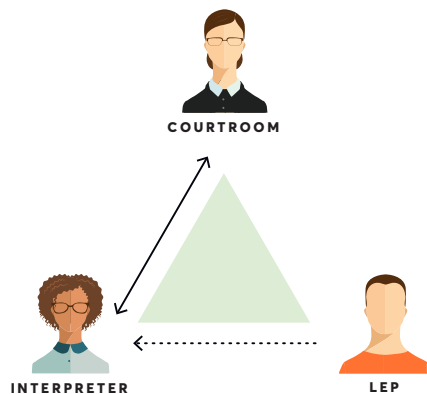
SIMULTANEOUS TO LEP is when the interpreter can hear the courtroom Audio and relay to the lep in their native tongue what is being said. The lep can communicate back to the interpreter as well. This is The mode the interpreter will use for a majority of the hearing.

SIMULTANEOUS TO COURT is the inverse of simultaneous. The interpreter would use interpretation mode when they Need to simultaneously relay back to the courtroom what the lep has Stated to them. This mode is only required if the lep is providing a longer than normal response.

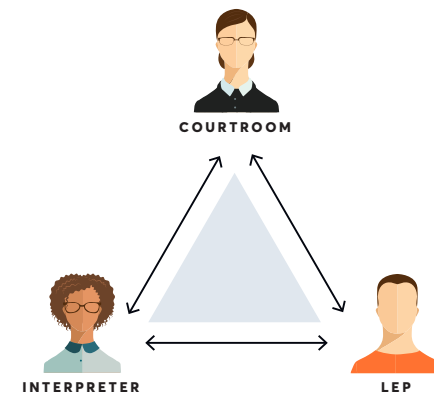
Finally, **CONSECUTIVE MODE** is when all parties can be heard.

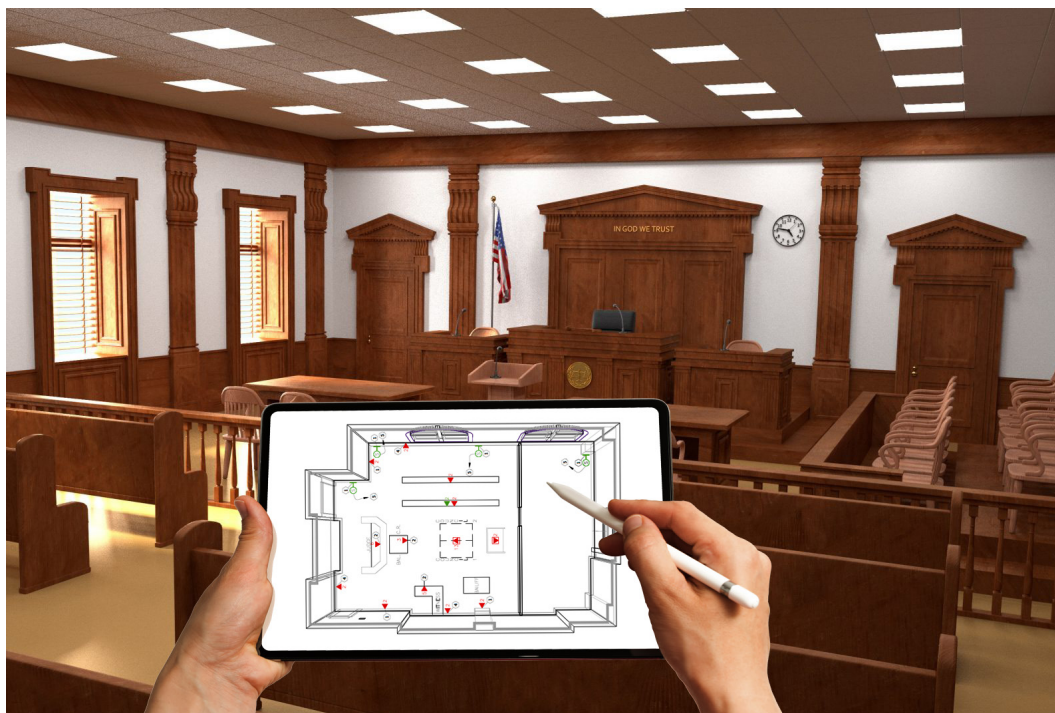
