## AMENDMENT NO. 5 TO CONTRACT NO. 128340, RELEASE NO. C-1121(5)

**THIS AMENDMENT** is by and between the State of Minnesota, acting through its Commissioner of Administration ("State"), and Carahsoft Technology Corp., 1860 Michael Faraday Dr., Suite 100, Reston, VA 20190 ("Contract Vendor").

**WHEREAS**, the State has a Contract with the Contract Vendor identified as Contract No. 128340, August 16, 2017, through July 31, 2022 ("Contract"), to provide Public Cloud Hosting Services; and

**WHEREAS**, Minn. Stat. § 16C.03, subd. 5, affords the Commissioner of Administration, or delegate pursuant to Minn. Stat. § 16C.03, subd. 16, the authority to amend contracts; and

**WHEREAS**, the terms of the Contract allow the State to amend the Contract as specified herein, upon the mutual agreement of the Office of State Procurement and the Contract Vendor in a fully executed amendment to the Contract;

NOW, THEREFORE, it is agreed by the parties to amend the Contract as follows:

1. That Contract No. 128340 is extended through July 31, 2024, at the same prices, terms, and conditions.

This Amendment is effective beginning August 01, 2022 or upon the date that the final required signatures are obtained, whichever occurs later, and shall remain in effect through contract expiration, or until the Contract is canceled, whichever occurs first.

Except as herein amended, the provisions of the Contract between the parties hereto are expressly reaffirmed and remain in full force and effect.
